Horizon scanning

Africa - The small-scale revolution against big agriculture: five farmers talk greener, better food. The climate crisis, conflict and the dominance of multinationals with industrial-scale production for export have popularised the concept of agroecology – promoting small-scale farming and farmers, protecting biodiversity and adapting traditional methods that do away with the need for chemicals and expensive fertilisers. The Guardian spoke to five devotees of greener, better food.

Brazil- Indigenous organizations in the Brazilian state of Para said they were not consulted by the government before it signed a deal with multinational companies to sell carbon offset credits to support conservation of the Amazon rainforest in the state.

Canada - Canada's carbon tax is popular, innovative and helps save the planet – but now it faces the axe. As prime minister Justin Trudeau trails in polls, opposition seek to persuade voters environmental policy is a burden

EU - EU Commission Proposes Delay for Anti-Deforestation Law. The European Union's Deforestation-Free Products Regulation (EUDR) is a piece of legislation that required considerable study, negotiation, and compromise. It requires EU companies to ensure the wood, palm oil, soy, coffee, cocoa, rubber, and cattle they export, or import has been produced in conditions that respect environmental laws and laws on land use rights, and that the products were farmed on land that was not deforested after 2020. It also requires the European Commission to designate areas as "low, standard, or high risk" for deforestation and forest degradation using a country benchmarking process.

El Salvador - El Salvador faces scrutiny for 'political' trial of five environmental activists. Five environmental activists who helped secure a historic mining ban in El Salvador are facing life imprisonment for an alleged civil war-era crime, in a case that has been condemned by UN and legal experts as baseless and politically motivated.

Guatemala - Hudbay Minerals settles civil lawsuits filed in Canada over alleged abuses at Fenix nickel mine in Guatemala

India - The Fisherman and the Banker: film charts Indian fishers' fight with a giant. Filmed over a decade, "the Fisherman and the Banker" is modern-day David and Goliath documentary that chronicles the struggle of a fishing community in India's Gulf of Kutch who take on one of the world's most powerful institutions, The World Bank Group, after it funded a coal-fired power plant on their coast. They alleged that the construction of the plant had adversely affected their livelihoods by depleting fish populations and increasing salinity levels.

Ireland - Migrant worker working '70-hour weeks' for less than minimum wage awarded €23,000. The Workplace Relations Commission (WRC) ruled on Tuesday that Chicken Castle Limited, trading as Chicken Club, in Main Street, Castleisland, Kerry, had breached the employment rights of Suman Bhurtel, who was working with an employment permit as a Chef De Partie.

Russia - Unilever sells its subsidiary to local co., completes exit from country. The maker of Dove soap and Hellmann's condiments said the sale includes all of its business and four factories in Russia. Its business in Belarus is also included in the sale.

Saudi Arabia - MPs pile pressure on Labour to oppose Saudi bid to join UN's Human Rights Council. A letter to foreign secretary David Lammy – signed by MPs and peers from across parties – outlines concerns over the Kingdom's human rights record, including the jailing of women's rights advocates and a surge in executions.

Thailand - Authorities of Thailand are ramping up the crackdown on foreigners illegally working in the country, with a campaign launched by the Ministry of Labor to inspect workplaces employing migrant workers nationwide. Labor Minister Phiphat Ratchakitprakarn said from June 5 to Oct. 2, officials inspected 20,152 outlets employing 277,770 migrant workers, finding 844 workplaces employing illegal immigrant workers and arresting 2,063 individuals from some Southeast Asian countries and other nationalities.

UK - New UK laws to stop repeat of P&O mass sackings scandal go before parliament. Labour clamps down on poor working conditions at sea with laws on collective dismissal and minimum wage on cross-Channel ferries

UK - New enforcement agency will protect workers' rights as part of 'watershed' bill. Employment rights legislation has been widely heralded by trade unions despite some commitments being watered down. The Fair Work Agency will be created as part of the government's employment rights legislation, which will include stronger protections against unfair dismissal and exploitative contracts.

Mental Health - Today is World Mental Health Day The theme for 2024 is "It is time to prioritise mental health in the workplace".

Unseen - Helpline wins £1 million in funding to expand the fight against modern slavery. More people from hard-to-reach communities will be helped to escape exploitation thanks to new funding made possible by National Lottery players. The Helpline received a record number of calls and contacts via our web form and app in 2023. Our advisers handled 11,700 calls and contacts from potential victims and people requesting information and guidance, a 20% increase on the previous year.

Forced Labour Legislation in EU - Slavery no more? – EU adopts the FLR. Although sounding like a practice from a bygone age, forced labour – whereby individuals are compelled against their will to provide work or service through the use of force, fraud, or coercion – is still very much with us. Carbon Market – Mandatory Environmental and Human Rights Safeguards Agreed for UN. The Body mandated by the Paris Agreement to set up a new UN carbon market has agreed mandatory environmental and human rights safeguards early into a five-day meeting in Baku.

These protections will require those participating in the UN's Paris Agreement Crediting Mechanism to identify, evaluate, avoid, minimize and mitigate potential risks associated with projects.

The new rules mean environmental and social rights will be protected through a mandatory tool – known as the Sustainable Development Tool – that assesses and monitors project impacts throughout their lifespan.

Just Transition - Energy giants collaborate to safeguard nature and communities during green transition. As the transition to renewable energy grows, the World Economic Forum has launched

a new coalition assisting large developers in creating projects that benefit nature and local communities.

WWF - Nature is disappearing: The 2024 Living Planet Report is out, and the message is clear: Nature is in crisis. There has been a 73% decline in the average size of monitored wildlife populations since 1970. These declines are an early warning indicator of increasing extinction risk and the potential loss of ecosystem health and resilience. As vital ecosystems near collapse, we are dangerously close to tipping points that could lead to irreversible impacts for both people and the planet. The average size of wildlife populations has fallen by a staggering 73%.

IHRB - Seafarers and Illegal Recruitment Fees: 2024 Insights. New research for 2024 shows that almost a third (31%) of seafarers have been asked to pay a recruitment fee to secure a job onboard a merchant vessel - of these, 28% were asked in 2024 - meaning the problem is both endemic and current.

Climate Change and Modern Slavery Hub - Resource on the intersection between climate change, migration and modern slavery. Modern slavery – an umbrella term for several types of exploitation, including forced labour, and its forms, forced marriage, and human trafficking – and its enabling factors are complex and still poorly understood. This is especially true in the context of climate change, including climate-induced migration or immobility. This poor understanding results in the absence of policies and programmes that adequately protect and support people who are especially vulnerable, which enables the perpetuation of abuses and severe exploitation.

This website brings together the existing evidence on the link between climate change, migration and modern slavery. It aims to support informed decision making to reduce vulnerability to all forms of modern slavery, specifically in the context of climate change.
