Horizon scanning

Kenya - <u>G4S guards accused of brutal attack at Del Monte's Kenvan pineapple farm</u>. Previous guards on the Kenyan mega-farm were accused of killings. Now, security staff from new global contractor are accused of unprovoked violence

Peru - I've seen the dark, fat grease stuck to the leaves': oil and gas encroach on Peru's uncontacted peoples. The government is auctioning off plots of pristine Indigenous reserves for fossil fuel projects, with campaigners warning of a 'silent genocide'

Portugal - Portugal's Immigration Overhaul Hits South Asian Workers Hard. The possibility of a lifechanging "raspberry passport" through agricultural work is fading for many South Asian workers, forcing already vulnerable people into even more precarious and often exploitative situations.

Tunisia - EU refuses to publish findings of Tunisia human rights inquiry. The European Commission is refusing to publish the findings of a human rights inquiry into Tunisia it conducted shortly before announcing a controversial migration deal with the increasingly authoritarian north African country.

UK - What are the National Minimum Wage, National Living Wage and Real Living Wage? Almost half a million workers will benefit as the <u>Real Living Wage</u> - an hourly rate amount voluntarily paid by some UK businesses - is going up by 5%.

UK - <u>Employment Rights Bill: will new unfair dismissal rules help seasonal workers?</u> The new bill may yet improve the outlook for seasonal workers, as is desperately needed. But it will do nothing to fix the root cause of the problem: a short-term visa which gives their employer outsized power to decide where they work, if they work, and even whether they stay in the country.

UK- <u>Government provides certainty to horticulture and poultry businesses</u>. The Government has underlined its commitment to the horticultural and poultry sectors by confirming measures to provide stability, including the allocation for the Seasonal Worker visa route for 2025. A package of measures to provide certainty and stability to farmers and growers in the UK's horticulture, poultry and sheep sectors has been announced by the government today (Monday 21 October).

UK - <u>Seasonal worker scheme confirmed for 2025</u>. The scheme will provide a total of 43,000 seasonal worker visas for horticulture and 2,000 for poultry next year (Grocer)

UK - Labour backtracks on push for genocide ruling on China's treatment of Uyghurs. Labour has backtracked on plans to push for formal recognition of China's treatment of the Uyghurs as genocide in the run-up to David Lammy's trip to the country this weekend.

UK - Farmer fined £16k after worker dies in fall. 16-Oct-2024 By William Dodds. A farmer has been cleared of manslaughter but fined after a worker was killed on his farm in Cheshire while attempting to repair the roof of a packing shed.

UK - <u>New workers' rights 'to cost firms £5bn a year'.</u> Labour's plans to upgrade workers' rights will cost businesses up to £5bn a year to implement, according to the government's own analysis. The new measures would have a disproportionate impact on smaller businesses, responsible for employing 13 million workers, the impact assessment report found.

USA - <u>Safeway supplier Humberto Castaneda violated "numerous" labour requirements for H2-A seasonal</u> farmworkers; Safeway owner is Albertsons. The US Department of Labor (DoL) has fined grower Humberto Castaneda Produce USD31,102 in back wages and USD18,154 in civil penalties having established numbers abuses of H2-A seasonal farmworkers employed at the farm. These included findings that the employer paid higher rates to workers with H2-A visas than to local workers, failed to provide tools, meals or kitchen facilities to workers, housed workers in "dilapidated trailers" and did not reimburse inbound and outbound transportation costs.</u>

Global Water Crisis - <u>Global water crisis leaves half of world food production at risk in next 25 years</u>. Half the world's population already faces water scarcity, and that number is set to rise as the climate

crisis worsens, according to a report from the Global Commission on the Economics of Water published on Thursday. Demand for fresh water will outstrip supply by 40% by the end of the decade, because the world's water systems are being put under "unprecedented stress", the report found.
