International regulatory frameworks

In summary; because the national legislative frameworks can be complex and not necessarily accessible for companies working in an international context, it was discussed in the webinar that where national regulation was unclear/conflicting to follow international frameworks.

- International Financial Corporation (IFC) Performance Standards 7 on indigenous peoples, which requires indigenous peoples' Free Prior & Informed Consent.
